## "HEALTHCARE" Chapter 15 Summary THE 1619 PROJECT

The historic New York Times', "The 1619 Project", created by Nikole Hannah-Jones, is now available as a book of the same name, with additional articles. Chapter 15 captures, **BLACK HEALTH and WELLNESS**, the **Black History Month** theme. Here are some highlights:

- Obamacare, (ACA), faced repeated repeals and replacements during and after President Obama's administration. Age, income, employment status and geographic regions marginalized African Americans, Latino Americans, Indian Americans and others. These groups constituted the highest medically uninsured and suffered disproportionate rates of chronic disease and death.
- Twelve states, mostly red states refused to participate in **ACA** which provided health coverage to low-income Americans.
- Reconstruction following the Civil War was short lived that, in part, addressed healthcare for former slaves. Under Reconstruction, the Freedmen's Bureau erected approximately 40 hospitals to provide healthcare for former slaves, but restrictions and racist laws were passed to prevent and deny needed care.
- Rebecca Lee Crumpler, the nation's first Black female doctor, trained and worked in Boston, joined the Freedmen's Bureau and was a strong advocate for healthcare for former slaves. The National Medical Association (NMA) was founded by Black doctors in 1895, the year of Dr. Crumpler's death. NMA was a leading voice for health and medical treatment for Blacks and disadvantaged groups.
- During the 1930's, Blacks were excluded from the **New Deal** and the **Social Security Act**, as well as **The Wagner Act** which ensured collective bargaining for workers as well as **The Labor Standards Act** (minimum wage and 8-hour workday.)
- The **Hill-Burton Act** that provided federal grants for hospital construction in communities in need was controlled by state leaders that neglected Black Americans in rural communities.
- During World War II, the American Medical Association (AMA) allowed the exclusion of Black doctors and Black medical students from admission to medical schools. They were left to train and practice in only segregated hospitals and health clinics. [My late friend's training ground, Homer G. Phillips Hospital & Medical School (1937-1979) in St. Louis, Missouri, was a segregated facility that produced many qualified Black medical doctors, nurses, dentists and staff. It provided healthcare for thousands of the colored population, as did other such institutions.]
- From the 1895 to date, the **National Medical Association** of Black doctors has promoted healthcare as a basic human right. Together, Medicare and Medicaid helped bring hospital segregation to an end.

The **1964 Civil Rights Act** outlawed segregation for any entity receiving federal funds that helped low income and the elderly. *I say, this law must be protected and guarded.*

### OBAMA: THE CORNER STONE

Dr. Carter G. Woodson initiated Negro History Week in February 1926. 2022 marks the 96<sup>th</sup> observation of what has become Black History Month. The 2022 theme is Black Health and Wellness. The theme is designed to cast light on the healthcare and the associated social and economic determinants impacting the African American community.

Healthcare for profit is a major stumbling block which, I say, must be watched and

Good health, a condition of the body and the degree to which it is free from illness is intimately linked to wellness, a state of being healthy achieved by the personal efforts of an individual. A lack of awareness of the importance of good health and wellness not only impacts the individual but also the family and the greater community. A major hurdle for all members of the minority community is the inability to obtain health insurance to ensure access to healthcare, a cornerstone to good health and wellness.

In July 2009, an effort to overhaul the healthcare system, following the efforts of past presidents, HR3962, the Affordable Health Care for Americans Act, was introduced. This was signed into law by President Barack Obama on March 23, 2010. It is more commonly known as the affordable Care Act (ACA) or "Obamacare". This changed the healthcare system in the U.S. by reducing the amount that individuals and families paid in uncompensated care. The Act required every American to have healthcare insurance and provided assistance to those who could not afford a plan. It also covered individuals with pre-existing conditions. The ACA was modified in 2017 when congress repealed the rule that everyone in the country was required to have healthcare.

Today, despite efforts by many politicians to eliminate affordable healthcare, Obamacare is still available, representing one of the greatest overhauls of the U.S. healthcare systems providing coverage for over 94% of Americans. Obamacare has become the cornerstone for good health.

The current exhibit, **Obama, the Legend** at the Society gallery celebrates President Obama, the first African American president, not just for Obamacare but showcases highlights of his 8 years in office. We invite you to visit the gallery to enjoy the exhibit as soon as the AAACC facilities are open.

### BLACK HEALTH AND WELLNESS – 2022 BHM THEME

The 2022 Black History Month Theme is **Black Health and Wellness.** According to ASALH, the national organization established by Carter G. Woodson,

This theme acknowledges the legacy of... Black scholars and medical practitioners in Western medicine, ... (and) birthworkers, doulas, midwives, naturopaths, herbalists, etc., throughout the African Diaspora. The 2022 theme considers activities, rituals and initiatives that Black communities have done to be well.

Thus, our Kick-Off speaker, Dr. Johnathan Butler of UCSF, cited our African roots, focused on mental health, and broadly defined health and wellness to include inordinate stress, food insecurity, low or no pay, lack of decent and affordable shelter, etc. These, combined, influence our physical and mental health. The COVID epidemic has further challenged our heightened susceptibility to early morbidity and long-term illness. We must strive to address these inequities.


